After pioneering the SPAC in 1993, Graubard Miller handled all 15 SPAC IPOs consummated during the 1990s and more SPAC-related business combinations during that time than any other law firm.

In the new millennium, as the vehicle has become widely accepted, we continue to be the leading SPAC law firm – handling more than 80 consummated IPOs (for both issuers and underwriters) since 2003 and more than 30 successful business combinations since 2005, or approximately one-third of all SPAC activity in the market. In fact, Graubard Miller has handled more than twice the number of SPAC IPOs and business combinations handled by any other law firm in the world. In 2015, we represented either the issuer or the underwriter in nine of the 20 consummated U.S. SPAC IPOs, and were counsel in five of the nine consummated SPAC business combinations.

In connection with consummated IPOs, we have handled a variety of structures, including IPOs where only shares are sold, where units made up of shares and warrants (or a fraction thereof) are sold and where units made up of shares and rights are sold. Graubard Miller actually developed the use of rights by SPACs, paving the way for a SPAC with potentially reduced dilution and a cleaner capital structure. We continue to be at the forefront of SPAC evolution in terms of making our SPAC issuers as attractive as possible to potential targets.

In connection with consummated business combinations, we have handled a variety of transaction structures, including the prototypical SPAC stockholder-approved business combination, as well as business combinations consummated through tender offers. We have also handled a variety of "add-on" features such as simultaneous or post-closing PIPEs and warrant tender offers or exchanges. We continue to provide our SPAC clients with cutting edge advice to assist them in structuring and consummating their business combinations so they are received favorably by the street.
